<u>ORDER</u>

A status conference was held on this date with counsel for all parties participating. The Court inquired as to the existence of any discovery disputes relative to the upcoming hearings. The parties informed the Court that the audit discussed at the previous hearing has not yet been provided to them. The United States of America ("United States") informed the Court that it has not yet received the documents relied on and referenced by the experts for the Sheriff of Orleans Parish ("Sheriff") and the City of New Orleans ("City"). The parties did not report any additional discovery disputes. Counsel for the City reiterated that the Sheriff and the City have agreed to commit to a plan relative to the new Orleans Parish Prison ("OPP") facility on or before Wednesday, July 10, 2013.¹

IT IS ORDERED that the Sheriff and the City shall inform the Court and the other parties of their plan with respect to the new OPP facility on or before **Thursday**, **July 11**, **2013**, **at 9:00 a.m.**

IT IS FURTHER ORDERED that the Sheriff shall provide a copy of the audit to the other parties today, **Tuesday**, **July 2**, **2013**.

IT IS FURTHER ORDERED that, with respect to the August 5 hearing, the Sheriff shall provide the documents underlying its expert report(s) to the United States on or before Wednesday, July 3, 2013, at 5:00 p.m. To the extent the United States already possesses certain documents, the Sheriff shall identify them with sufficient specificity to permit their timely retrieval.

IT IS FURTHER ORDERED that, with respect to the August 5 hearing, the City shall provide the documents underlying its expert report(s), including any documents relative to a PFM cost analysis, to the United States on or before **Tuesday**, **July 9**, **2013**. To the extent the United States already possesses certain documents, the City shall identify them with sufficient specificity to permit their timely retrieval.

IT IS FURTHER ORDERED that, with respect to the August 5 hearing, the City may file a motion asserting work product privilege on or before **Tuesday**, **July 9**, **2013**. Any opposition shall be filed on or before **Friday**, **July 12**, **2013**.

IT IS FURTHER ORDERED that the deadlines² for the August 5 hearing are amended as follows:

All documents to be introduced at the August 5, 2013 hearing not otherwise produced shall be exchanged by the parties on or before **Tuesday**, **July 9, 2013**.

Memoranda of law supporting objections to any exhibits shall be filed on or before **Friday**, **July 12, 2013**. Memoranda of law in opposition shall be filed on or before **Tuesday**, **July 16, 2013**. The Court will not consider untimely objections.

All motions *in limine* shall be filed with the Court on or before **Monday**, **July 15**, **2013**. Memoranda of law in opposition shall be filed on or before **Wednesday**, **July 17**, **2013**. The Court may refuse to grant requests that could and should have been raised in a timely motion *in limine*.

All depositions shall be completed on or before Friday, July 19, 2013.

Any motion relative to the parties' experts shall be filed on or before Monday, July 22,

2013, at 9:00 a.m. Any opposition shall be filed on or before Wednesday, July 24, 2013, at 5:00 p.m.

The parties shall submit a proposed pre-hearing order on or before Monday, July 22, 2013.

Bench books of all proposed exhibits shall be delivered to the Court on or before

Wednesday, July 24, 2013.

IT IS FURTHER ORDERED that all other deadlines remain in effect.
