
**JOINT NOTICE EXTENDING TIME PERIOD
FOR ENROLLMENT IN SECOND MDL RESOLUTION PROGRAM**

Defendants' Liaison Counsel, Plaintiffs' Liaison Committee and the State Liaison Committee (collectively the "Parties") hereby provide notice that they have extended the time period for enrollment in the Second MDL Resolution Program ("the Second Program") as follows:

- (1) On December 19, 2005, the Court entered a Consent Order regarding the Second Program.
- (2) Enrollment was originally scheduled to remain open until June 17, 2006, to allow the parties to reach the minimum enrollment levels required to make the Second Program effective.
- (3) The Parties have extended the timeframe for enrollment from June 17, 2006 to September 15, 2006.






