PRETRIAL ORDER NO. 3

On March 31, 2022, this Court appointed Karen Cannon Shanks as Plaintiffs' Liaison Counsel and Douglas Moore as Defendants' Liaison Counsel, as reflected in the Minute Entry for the Initial Pretrial Conference (Doc. 11) and Pretrial Order No. 2 (Doc. 14). At this time, the Court finds that this litigation requires a separate appointment of liaison counsel for the 505(b)(2) Defendants, pursuant to Pretrial Order No. 1 (Doc. 5).

Applications and nominations for the designation of liaison counsel must be filed electronically in the master docket by **March 18, 2023**. On the day of filing, notice must also be served upon Plaintiffs' Liaison Counsel, Plaintiffs' Steering Committee, and Defendants' Liaison Counsel, all named in Attachment A. Named Counsel are then responsible for circulating notice to all Plaintiffs' and Defendants' Counsel. No submissions longer than four (4) pages will be considered. The Court shall appoint liaison counsel for the 505(b)(2) Defendants after full consideration of the proposals.
