JOINT NOTICE EXTENDING TIME PERIOD TO FILE CLAIM FORMS

Defendants' Liaison Counsel and Plaintiffs' Liaison Counsel (collectively the "Parties") hereby notify Enrollees in the MDL Settlement Program ("the "Program") that they have agreed to extend the time-period for the filing of Claim Forms as follows:

- (1) The Parties provided notice that the Program's minimum enrollment levels were reached on April 13, 2005.
- (2) Under paragraph 7 of the Term Sheet, an Enrollee shall have 120 days from the date of minimum enrollment (April 13, 2005) or from the date the enrollee serves an Enrollment Form, whichever is later, to serve a Claim Form.
- (3) For those Enrollees who served Enrollment Forms on or before April 13, 2005, the time-period for them to serve Claim Forms is extended 60 days, or from August 11, 2005, to October 10, 2005.

- (4) For those Enrollees who served Enrollment Forms after April 13, 2005, the time period for them to serve Claim Forms shall be either 120 days from the date of service of the Enrollment Form, or October 10, 2005, whichever is later.


