### **CMO 11 Deadlines and Obligations**

The following requirements and obligations apply to all plaintiffs with cases pending in the Xarelto MDL who have not enrolled in the Xarelto settlement program.

Please note that many of the CMO 11 deadlines are divided between "Existing Plaintiffs" and "New Plaintiffs." CMO 11 defines "Existing Plaintiffs" as "Plaintiffs who filed suit on or before March 11, 2019." See CMO 11 Section I(A)(i). CMO 11 defines "New Plaintiffs" as "Plaintiffs who filed suit after March 11, 2019." See CMO 11 Section I(A)(ii). Plaintiffs are advised to consult CMO 11 for the specific requirements associated with each obligation and the deadlines for each obligation that apply to each particular plaintiff.

### 1. Obligations regarding filing fees.
